

TERMS AND CONDITIONS FOR THE PURCHASE OF GOODS AND SERVICES

1 Contract Formation

- 1.1 These terms and conditions apply to each Binding Order between the Logic Fire and Security and the Supplier for the supply of Goods and Services and Services to the exclusion of any other terms that the Supplier seeks to impose or incorporate, or which are implied by trade, custom, practice or course of dealing.
- 1.2 Each Purchase Order shall constitute an offer by the Logic Fire and Security to purchase the Goods and Services in accordance with these terms and conditions.
- 1.3 The Purchase Order shall be deemed to be accepted, and an individual contract formed ("Binding Order"), on the earlier of:
 - 1.3.1 the Supplier issuing a written acceptance of the Purchase Order;
 - 1.3.2 the Supplier verbally confirming its acceptance of the Purchase Order to the Logic Fire and Security Ltd; or
 - 1.3.3 the Supplier doing any act consistent with fulfilling the Purchase Order.

2 The Goods and Services

- 2.1 The Supplier shall ensure that the Goods and Services:
 - 2.1.1 are new (unless expressly agreed otherwise);
 - 2.1.2 correspond with their description, any sample provided and any applicable Specification (to include, without limitation, the provisions of the Logic Fire and Security Ltd's requirements set out in the Specification and the Supplier's response to such requirements);
 - 2.1.3 be of satisfactory quality (within the meaning of the Sale of Goods and Services Act 1979, as amended) and fit for any purpose held out by the Supplier or made known by the Supplier to the Logic Fire and Security Ltd expressly or by implication, and in this respect the Logic Fire and Security Ltd relies on the Supplier's skill and judgment;
 - 2.1.4 be free from defects in design, material and workmanship and remain so for a reasonable period after delivery commensurate to the nature, specification and Price of the Goods and Services;
 - 2.1.5 are manufactured and stored prior to delivery in accordance with Good Industry Practice;
 - 2.1.6 comply with all applicable statutory and regulatory requirements relating to the manufacture, labelling, packaging, storage, handling and delivery of the Goods and Services.
 - 2.1.7 All services performed under this agreement shall be performed will all due skill and care, in a good and workmanlike manner and otherwise in line with best practice within its industry ("Best Industry Practice")
 - 2.1.8 The supplier personnel will possess the qualification, professional competence and experience to carry out such services in accordance with Best Industry Practice.

- 2.1.9 the services will not in any way infringe or violate any Intellectual Property Rights, trade secrets or rights in proprietary information, nor any contractual, employment or property rights, duties of non-disclosure or other rights of any third parties; and
- 2.1.10 it has full capacity and authority to enter into this Agreement and that it has or will obtain prior to the commencement of the services, any necessary licences, consents and permits required of it for the performance of the services.
- 2.1.11 The Supplier shall ensure that it has and maintains all relevant consents, authorisations, licences and accreditations required to supply and deliver the Goods and Services prior to the delivery of any Goods and Services to the Logic Fire and Security Ltd.
- 2.1.12 The Supplier agrees to use reasonable endeavours to assign to the Logic Fire and Security Ltd upon request the benefit of any warranty, guarantee or similar right which it has against any third-party manufacturer or supplier of the Goods and Services in full or part.
- 2.1.13 The Supplier shall provide the Buyer with such progress reports, evidence or other information concerning the services as may be requested by the Buyer from time to time
- 2.1.14 The Supplier shall be responsible for maintaining such insurance policies in connection with the provision of the services as may be appropriate or as the Buyer may require from time to time.

2.2

2.2.1 The Supplier shall procure that the Supplier Personnel take all reasonable steps to safeguard their own safety and the safety of any other person who may be affected by their actions, and the Supplier agrees to indemnify and keep indemnified the Buyer from all and any liabilities, obligations, costs and expenses whatsoever arising from any loss, damage or injury caused to the Buyer or any third party by the Supplier Personnel.

3 Delivery

- 3.1 The Supplier shall deliver the Goods and Services in accordance with any delivery timescales, delivery dates and delivery instructions (to include, without limitation, as to delivery location and delivery times) set out in the Purchase Order or as otherwise agreed with the Logic Fire and Security Ltd in writing. If no such date is specified or agreed then the Supplier shall deliver the Goods and Services during Normal Working Hours within 28 days of the date of the Purchase Order.
- 3.2 Delivery shall be completed when the Goods and Services have been unloaded at the location specified by the Logic Fire and Security Ltd and such delivery has been received by a duly authorised agent, employee or location representative of the Logic Fire and Security Ltd. The Logic Fire and Security Ltd shall procure that such duly authorised agent, employee Terms & Conditions for the Supply of Goods and Services or location representative of the Logic Fire and Security Ltd is at the delivery location at the agreed delivery date and times in order to accept such delivery. Any arrangement by which the Goods and Services are collected by the Logic Fire and Security Ltd in return for a discount on the Price shall be agreed by the Parties in writing (where due to an emergency such arrangements cannot be committed to writing prior to collection, the Parties shall confirm such arrangements in writing as soon as possible following collection). Where the Logic Fire and Security Ltd collects the Goods and Services, collection is deemed delivery for the purposes of these Terms and Conditions.

- 3.3 The Supplier shall ensure that a delivery note shall accompany each delivery of the Goods and Services. Such delivery note shall, as a minimum, contain the Logic Fire and Security Ltd's Purchase Order number, the name and address of the Logic Fire and Security Ltd, the name and address of the Supplier, a description and quantity of the Goods and Services, and shall show separately any extra agreed charges for containers and/or any other item not included in the Price or, where no charge is made, whether the containers are required to be returned.
- 3.4 Unless otherwise agreed with the Logic Fire and Security Ltd in writing, the Supplier shall be responsible for carriage, insurance, transport, all relevant licences, all related costs, and all other costs associated with the delivery of the Goods and Services to the delivery location and unloading of the Goods and Services at that location. Without limitation to the foregoing provision of this Clause 3.4, unless otherwise agreed with the Logic Fire and Security Ltd in writing, the Supplier shall be responsible for obtaining all export and import licences for the Goods and Services and shall be responsible for any delays to the delivery time due to such licences not being available when required. In the case of any Goods and Services supplied from outside the European Union, the Supplier shall ensure that accurate information is provided to the Logic Fire and Security Ltd as to the country of origin of the Goods and Services.
- 3.5 All third party carriers engaged to deliver the Goods and Services shall at no time be an agent of the Logic Fire and Security Ltd and accordingly the Supplier shall be liable to the Logic Fire and Security Ltd for the acts and omissions of all third party carriers engaged to deliver the Goods and Services to the Logic Fire and Security Ltd.
- 4 Passing of risk and ownership Title to and risk in the Goods and Services shall pass to the Logic Fire and Security Ltd when the Goods and Services are delivered to the Logic Fire and Security Ltd.
- 5 Inspection, rejection, return and recall
 - 5.1 Subject to reasonable written notice, the Supplier shall permit any person authorised by the Logic Fire and Security Ltd, to inspect work being undertaken in relation to the Goods and Services and/or the storage facilities used in the storage of the Goods and Services at all reasonable times at the Supplier's premises or at the premises of any subcontractor or agent of the Supplier in order to confirm that the Goods and Services are being manufactured and/or stored in accordance with Good Industry Practice and in compliance the requirements of these Terms and Conditions and any Specification.
 - 5.2 Without prejudice to the provisions of Clause 5.6 and subject to Clause 5.7, the Logic Fire and Security Ltd may by written notice reject any Goods and Services found to be damaged or otherwise not in accordance with the requirements of these Terms and Conditions and any Specification ("Rejected Goods and Services"). The whole of any delivery may be rejected if a reasonable sample of the Goods and Services in that delivery is found not to conform in all material respects to the requirements of these Terms and Conditions and any Specification.
 - 5.3 Without prejudice to the provisions of Clause 5.5, upon the rejection of any Goods and Services in accordance with Clauses 5.2 and/or 5.6, the Supplier shall, at the Logic Fire and Security Ltd's written request:
 - 5.3.1 collect the Rejected Goods and Services at the Supplier's risk and expense within ten (10) Business Days of issue of written notice from the Logic Fire and Security Ltd rejecting the Goods and Services; and
 - 5.3.2 without extra charge, promptly (and in any event within twenty (20) Business Days or such other time agreed by the Parties in writing acting reasonably) supply replacements for the Rejected Goods and Services to the Logic Fire and Security Ltd subject to the Logic Fire and Security Ltd not cancelling its purchase obligations in accordance with Clause 5.5.

- Risk and title in respect of any Rejected Goods and Services shall pass to the Supplier on the earlier of: (a) collection by the Supplier in accordance with Clause 5.3; or (b) immediately following the expiry of ten (10) Business Days from the Logic Fire and Security Ltd issuing written notification rejecting the Goods and Services. If Rejected Goods and Services are not collected within ten (10) Business Days of the Logic Fire and Security Ltd issuing written notification rejecting the Goods and Services, the Logic Fire and Security Ltd may return the Rejected Goods and Services at the Supplier's risk and expense and/or charge Terms & Conditions for the Supply of Goods and Services the Supplier for the cost of storage from the expiry of ten (10) Business Days from the date of notification of rejection.
- 5.5 Where Logic Fire and Security Ltd rejects any Goods and Services in accordance with Clauses 5.2 and/or 5.6 and the Logic Fire and Security Ltd does not require replacement Goods and Services, the Logic Fire and Security Ltd may by written notice cancel its purchase obligations in relation to such quantity of Rejected Goods and Services. Should the Logic Fire and Security Ltd have paid for such.
- 5.6 Rejected Goods and Services the Supplier shall refund such payment to the Logic Fire and Security Ltd within thirty (30) days of the Logic Fire and Security Ltd cancelling such purchase obligations and informing the Supplier that the Logic Fire and Security Ltd does not require replacements for such Rejected Goods and Services.
- 5.7 Without prejudice to any other provisions of these Terms and Conditions or any other warranties or guarantees applicable to the Goods and Services supplied and subject to Clauses 5.7 and 5.8, if at any time following the date of the delivery of any Goods and Services, all or any part of such Goods and Services are found to be defective or otherwise not in accordance with the requirements of these Terms and Conditions ("Defective Goods and Services"), the Supplier shall, at the Logic Fire and Security Ltd's discretion:
 - 5.7.1 upon written request and without charge, promptly (and in any event within twenty (20) Business Days or such other time agreed by the Parties in writing acting reasonably) remedy the deficiency by repairing such Defective Goods and Services; or
 - 5.7.2 upon written notice of rejection from the Logic Fire and Security Ltd, treat such Defective Goods and Services as Rejected Goods and Services in accordance with Clauses 5.2 to 5.5 (inclusive).
- 5.8 The Supplier shall be relieved of its liabilities under Clauses 5.2 to 5.5 (inclusive) and/or Clause 5.6 to the extent only that the Goods and Services are damaged, there are defects in the Goods and Services and/or the Goods and Services fail to comply with the requirements of these Terms and Conditions to the extent due, in each case, to any acts or omissions of the Logic Fire and Security Ltd.
- 5.9 The Logic Fire and Security Ltd's rights and remedies under Clause 5.6 shall cease within a reasonable period of time from the date on which the Logic Fire and Security Ltd discovers or might reasonably be expected to discover that the Goods and Services are Defective Goods and Services or within such other period as may be set out as part of the Logic Fire and Security Ltd's requirements in the Specification, if any. For the avoidance of doubt, Goods and Services not used before their expiry date shall in no event be considered Defective Goods and Services following the date of expiry provided that at the point such Goods and Services were delivered to the Logic Fire and Security Ltd they met any shelf life requirements set out in the Purchase Order or any Specification.

- 5.10 Where the Supplier is required by Law, Guidance, and/or Good Industry Practice to order a product recall ("Requirement to Recall") in respect of the Goods and Services, the Supplier shall:
 - 5.10.1 promptly (taking into consideration the potential impact of the continued use of the Goods and Services, service users and the Logic Fire and Security Ltd as well as compliance by the Supplier with any regulatory requirements) notify the Logic Fire and Security Ltd in writing of the recall together with the circumstances giving rise to the recall:
 - 5.10.2 from the date of the Requirement to Recall treat the Goods and Services the subject of such recall as Defective Goods and Services in accordance with Clause 5.6;
 - 5.10.3 consult with the Logic Fire and Security Ltd as to the most efficient method of executing the recall of the Goods and Services and use its reasonable endeavours to minimise the impact on the Logic Fire and Security Ltd of the recall; and
 - 5.10.4 indemnify and keep the Logic Fire and Security Ltd indemnified against, any loss, damages, costs, expenses (including legal costs and expenses), claims or proceedings suffered or incurred by the Logic Fire and Security Ltd as a result of such Requirement to Recall.
- 6 Price and payment
 - 6.1 The Price shall be calculated as set out in the Purchase Order or Specification.
 - 6.2 Unless otherwise agreed, the Price:
 - 6.2.1 shall remain fixed; and Terms & Conditions for the Supply of Goods and Services
 - 6.2.2 is the entire price payable by the Logic Fire and Security Ltd to the Supplier in respect of the provision of the Goods and Services and includes, without limitation:
 - 6.2.2.1 packaging, packing materials, addressing, labelling, loading, delivery to and unloading at the delivery location, all appropriate tax and duty (excluding VAT), any installation costs and associated works, the costs of all associated documentation and information supplied or made accessible to the Logic Fire and Security Ltd in any media, and any training in relation to the use, storage, handling or operation of the Goods and Services;
 - 6.2.2.2 any royalties, licence fees or similar expenses in respect of the making, use or exercise by the Supplier of any Intellectual Property Rights, and any licence rights granted to the Logic Fire and Security Ltd in accordance with Clause 7; and
 - 6.2.2.3 costs and expenses in relation to supplies and materials used by the Supplier or any third party in the manufacture of the Goods and Services, and any other costs incurred by the Supplier in association with the manufacture, supply or installation of the Goods and Services.
 - 6.3 Unless otherwise agreed:
 - 6.3.1 where the Purchase Order and/or Specification confirms that the payment profile for the Goods and Services is monthly in arrears, the Supplier shall invoice Logic Fire and Security Ltd, within five (5) days of the end of each calendar month, the Price (plus any applicable VAT thereon) in respect of the Goods and Services supplied in the preceding calendar month;

- 6.3.2 where Clause 6.3.1 does not apply, the Supplier shall invoice the Logic Fire and Security Ltd for Goods and Services for the Price (plus any applicable VAT thereon) at any time following completion of the supply of those Goods and Services in compliance with these Terms and Conditions and any Specification;
- 6.3.3 each invoice shall be a valid VAT invoice and shall contain such information and be addressed to such individual as the Logic Fire and Security Ltd may inform the Supplier from time to time. Invoices shall show the VAT calculations as a separate line item.
- The Logic Fire and Security Ltd shall pay each undisputed invoice received in accordance with Clause 6.3 within thirty (30) days of receipt of such invoice at the latest.
- 6.5 The Logic Fire and Security Ltd reserves the right to deduct any monies due to the Supplier from the Logic Fire and Security Ltd from any monies due to the Logic Fire and Security Ltd from the Supplier.

7 Intellectual property

Unless specified otherwise in any Specification, the Supplier hereby grants to the Logic Fire and Security Ltd, for the life of the use of Goods and Services by the Logic Fire and Security Ltd, an irrevocable, royalty-free, non-exclusive licence of any Intellectual Property Rights required for the purposes of receiving and using, and to the extent necessary to receive and use, the Goods and Services (to include any associated technical or other documentation and information supplied or made accessible to the Logic Fire and Security Ltd in any media) in accordance with these Terms and Conditions and any Specification.

8 Cancellation of Binding Orders

8.1 The Logic Fire and Security Ltd may cancel any Binding Order in whole or in part at any time before delivery with immediate effect by giving the Supplier written notice, whereupon the Supplier shall discontinue all work on the Binding Order. The Customer shall pay the Supplier fair and reasonable compensation for any work in progress on the Goods and Services at the time of termination of that Binding Order but such compensation shall not include loss of anticipated profits or any consequential or indirect loss.

9 Packaging, identification and end of use

- 9.1 The Supplier shall comply with all obligations imposed on it by Law relevant to the Goods and Services in relation to packaging, identification, and obligations following end of use by the Logic Fire and Security Ltd.
- 9.2 Unless otherwise specified in any Specification or otherwise agreed with the Logic Fire and Security Ltd in writing, the Goods and Services shall be securely packed in trade packages of a type normally used by the Supplier for Terms & Conditions for the Supply of Goods and Services commercial deliveries of the same or similar Goods and Services either in retail or in bulk quantities within the United Kingdom.
- 9.3 All Goods and Services that customarily bear any mark, tab, brand, label, serial numbers or other device indicating place of origin, inspection by any government or other body or standard of quality must be delivered with all the said marks, tabs, brands, labels, serial numbers or other devices intact. Without prejudice to the generality of the foregoing, the Supplier shall label all Goods and Services supplied to the Logic Fire and Security Ltd, and the packaging of such Goods and Services, to highlight environmental and safety information as required by applicable Law.

9.4 Unless otherwise set out in any Specification or agreed with the Logic Fire and Security Ltd in writing, the Supplier shall collect without charge any returnable containers (including pallets) within twenty one (21) days of the date of the relevant delivery. Empty containers not so removed may be returned by the Logic Fire and Security Ltd at the Supplier's expense or otherwise disposed of at Logic Fire and Security Ltd's discretion. The Supplier shall credit the Logic Fire and Security Ltd in full for any containers for which the Logic Fire and Security Ltd has been charged upon their collection or return.

10 Electronic product information

- 10.1 Where requested by Logic Fire and Security Ltd, the Supplier shall provide the Logic Fire and Security Ltd the Product Information in such manner and upon such media as agreed between the Supplier and the Logic Fire and Security Ltd from time to time for the sole use of the Logic Fire and Security Ltd.
- 10.2 The Supplier warrants that the Product Information is complete and accurate as at the date upon which it is delivered to the Logic Fire and Security Ltd and that the Product Information shall not contain any data or statement which gives rise to any liability on the part of the Logic Fire and Security Ltd following publication of the same in accordance with Clauses 10.4 and 10.5.
- 10.3 If the Product Information ceases to be complete and accurate, the Supplier shall promptly notify the Logic Fire and Security Ltd in writing of any modification or addition to or any inaccuracy or omission in the Product Information.
- The Supplier grants the Logic Fire and Security Ltd a perpetual, non-exclusive, royalty-free licence to use and exploit the Product Information and any Intellectual Property Rights in the Product Information for the purpose of illustrating the range of Goods and Services and services (including, without limitation, the Goods and Services) available pursuant to the Logic Fire and Security Ltd's
- 10.5 contracts from time to time. Subject to Clause 10.5, no right to illustrate or advertise the Product Information is granted to the Supplier by the Logic Fire and Security Ltd, as a consequence of the licence conferred by this Clause 10.4.
- 10.6 Logic Fire and Security Ltd may reproduce for its sole use the Product Information provided by the Supplier in the Logic Fire and Security Ltd's product catalogue from time to time in electronic format and/or made available on the Logic Fire and Security Ltd's external website and/or made available on other digital media from time to time.
- 10.7 If requested in writing by Logic Fire and Security Ltd, and to the extent not already agreed as part of any Specification, the Supplier and the Logic Fire and Security Ltd shall discuss and seek to agree in good faith arrangements to use any Electronic Trading System.

11 Records retention

- Subject to any statutory requirement, the Supplier shall keep secure and maintain for at least six (6) years, or such longer period as may be agreed between the Parties, full and accurate records of all matters relating to the Goods and Services.
- 11.2 The Logic Fire and Security Ltd shall have the right to audit the Supplier's compliance with these Terms and Conditions and any Specification. The Supplier shall permit or procure permission for the Logic Fire and Security Ltd or its authorised representative during normal business hours having given advance written notice of no less than five (5) Business Days, access to any premises and facilities, books and records reasonably required to audit the

Supplier's compliance with its obligations under these Terms and Conditions and any Specification.

- 12 Notice Terms & Conditions for the Supply of Goods and Services
 - Any notice required to be given by either Party shall be in writing and shall be delivered by hand or sent by prepaid first class recorded delivery or by email to the person referred to in the Purchase Order or such other person as one Party may inform the other Party in writing from time to time or to a director of the relevant Party at the head office, main UK office or registered office of such Party.
 - 12.2 A notice shall be treated as having been received:
 - 12.2.1 if delivered by hand within normal business hours when so delivered or, if delivered by hand outside normal business hours, at the next start of normal business hours; or
 - 12.2.2 if sent by first class recorded delivery mail on a normal Business Day, at 9.00 am on the second Business Day subsequent to the day of posting, or, if the notice was not posted on a Business Day, at 9.00 am on the third Business Day subsequent to the day of posting; or
 - 12.2.3 If sent by email, if sent within normal business hours when so sent or, if sent outside normal business hours, at the next start of normal business hours provided the sender has either received an electronic confirmation of delivery or has telephoned the recipient to inform the recipient that the email has been sent.
- 13 Assignment, novation and subcontracting
 - 13.1 The Supplier shall not, except where Clause 13.2 applies, assign, subcontract, novate, create a trust in, or in any other way dispose of the whole or any part of the contract between Logic Fire and Security Ltd and the Supplier without the prior consent in writing of Logic Fire and Security Ltd. If the Supplier subcontracts any of its obligations, every act or omission of the subcontractor shall be deemed to be the act or omission of the Supplier and the Supplier shall be liable to the Logic Fire and Security Ltd as if such act or omission had been committed or omitted by the Supplier itself. 1
 - Any consent given by Logic Fire and Security Ltd for the Supplier to subcontract any of its obligations shall not impose any duty on the Logic Fire and Security Ltd to enquire as to the competency of any authorised subcontractor. The Supplier shall ensure that any authorised subcontractor has the appropriate capability and capacity to perform the relevant obligations and that the obligations carried out by such subcontractor are fully in accordance with those obligations.
 - 13.3 Where the Logic Fire and Security Ltd pays the Supplier's undisputed invoices earlier than thirty (30) days from receipt in accordance with any applicable government prompt payment targets, the Supplier shall use its reasonable endeavours to pay its relevant subcontractors within a comparable timeframe from receipt by the Supplier of such undisputed invoices from its subcontractors.
 - 13.4 Logic Fire and Security Ltd shall upon written request have the right to review any subcontract entered into by the Supplier in respect of the provision of the Goods and Services and the Supplier shall provide a certified copy of any subcontract within five (5) Business Days of the date of a written request from the Logic Fire and Security Ltd. For the avoidance of doubt, the Supplier shall have the right to redact any confidential pricing information in relation to such copies of subcontracts.

13.5 Logic Fire and Security Ltd may at any time transfer, assign, novate, subcontract or otherwise dispose of its rights and obligations under these Terms and Conditions or any part thereof and the Supplier warrants that it will carry out all such reasonable further acts required to effect such transfer, assignment, novation, subcontracting or disposal.

14 Prohibited Acts

- 14.1 The Supplier warrants and represents that:
 - 14.1.1 it has not committed any offence under the Bribery Act 2010 or done any of the following ("Prohibited Acts"):
 - 14.1.1.1 offered, given or agreed to give any officer or employee of the Logic Fire and Security Ltd any gift or consideration of any kind as an inducement or reward for doing or not doing or for having done or not having done any act in relation to the obtaining or performance of this or any other agreement with Logic Fire and Security Ltd or for showing or not showing favour or disfavour to any person in relation to this or any other agreement with the Logic Fire and Security Ltd; or Terms & Conditions for the Supply of Goods and Services
 - 14.1.1.2 in connection with this Contract paid or agreed to pay any commission other than a payment, particulars of which (including the terms and conditions of the agreement for its payment) have been disclosed in writing to Logic Fire and Security Ltd; and
 - 14.1.2 it has in place adequate procedures to prevent bribery and corruption, as contemplated by section 7 of the Bribery Act 2010.
- 14.2 If the Supplier or its Staff (or anyone acting on its or their behalf) has done or does any of the Prohibited Acts or has committed or commits any offence under the Bribery Act 2010 with or without the knowledge of the Supplier in relation to this or any other agreement with Logic Fire and Security Ltd:
 - 14.2.1 Logic Fire and Security Ltd shall be entitled:
 - 14.2.1.1 to terminate this Contract and recover from the Supplier the amount of any loss resulting from the termination;
 - 14.2.1.2 to recover from the Supplier the amount or value of any gift, consideration or commission concerned; and
 - 14.2.1.3 to recover from the Supplier any other loss or expense sustained in consequence of the carrying out of the Prohibited Act or the commission of the offence under the Bribery Act 2010;
 - 14.2.2 any termination under Clause 14.2.1.1 shall be without prejudice to any right or remedy that has already accrued, or subsequently accrues, to the Logic Fire and Security Ltd.

15 Confidentiality

15.1 In respect of any Confidential Information it may receive directly or indirectly from the other Party ("Discloser") and subject always to the remainder of this Clause 15, each Party ("Recipient") undertakes to keep secret and strictly confidential and shall not disclose any such

Confidential Information to any third party without the Discloser's prior written consent provided that the provisions of this Clause 15 shall not apply to any Confidential Information:

- 15.1.1 which is in or enters the public domain other than by breach of this Clause 15 or other act or omissions of the Recipient;
- 15.1.2 which is obtained from a third party who is lawfully authorised to disclose such information without any obligation of confidentiality;
- 15.1.3 which is authorised for disclosure by the prior written consent of the Discloser;
- 15.1.4 which the Recipient can demonstrate was in its possession without any obligation of confidentiality prior to receipt of the Confidential Information from the Discloser; or
- 15.1.5 which the Recipient is required to disclose purely to the extent to comply with the requirements of any relevant stock exchange.
- Nothing in this Clause 15 shall prevent the Recipient from disclosing Confidential Information where it is required to do so by judicial, administrative, governmental or regulatory process in connection with any action, suit, proceedings or claim or otherwise by applicable Law, including the Freedom of Information Act 2000 ("FOIA"), Codes of Practice on Access to Government Information, on the Discharge of Public Authorities' Functions or on the Management of Records ("Codes of Practice") or the Environmental Information Regulations 2004 ("Environmental Regulations").
- 15.3 Provided Logic Fire and Security Ltd makes clear the confidential nature of such information and that it must not be further disclosed except in accordance with Law or this Clause 15.3, the Logic Fire and Security Ltd may disclose the Supplier's Confidential Information to the following third parties:
 - 15.3.1 any consultant, contractor or other person engaged by Logic Fire and Security Ltd receiving such information; Terms & Conditions for the Supply of Goods and Services
 - 15.3.2 any relevant party for the purpose of the examination and certification of the Logic Fire and Security Ltd's accounts; or
 - 15.3.3 any relevant party for any examination pursuant to section 6(1) of the National Audit Act 1983 of the economy, efficiency and effectiveness with which the Logic Fire and Security Ltd has used its resources.
- The Supplier may only disclose Logic Fire and Security Ltd's Confidential Information, and any other information provided to the Supplier by Logic Fire and Security Ltd in relation to the provision of the Goods and Services, to the Supplier's Staff or professional advisors who are directly involved in the performance of or advising on the Supplier's obligations under these Terms and Conditions. The Supplier shall ensure that such Staff are aware of and shall comply with the obligations in this Clause 15 as to confidentiality and that all information, including Confidential Information, is held securely, protected against unauthorised use or loss and, at Logic Fire and Security Ltd's written discretion, destroyed securely or returned to Logic Fire and Security Ltd when it is no longer required. The Supplier shall not, and shall ensure that the Staff do not, use any of the Logic Fire and Security Ltd.'s Confidential Information received otherwise than for the purposes of performing the Supplier's obligations under these Terms and Conditions.
- 15.5 For the avoidance of doubt, save as required by Law, the Supplier shall not, without the prior written consent of the Logic Fire and Security Ltd (such consent not to be unreasonably

withheld or delayed), announce that it has been appointed as a Supplier to the Logic Fire and Security Ltd and/or make any other announcements about these Terms and Conditions.

- 15.6 Clause 15 shall remain in force:
 - 15.6.1 without limit in time in respect of Confidential Information which comprises Personal Data, Sensitive Personal Data or which relates to national security; and
 - 15.6.2 for all other Confidential Information for a period of three (3) years after the final delivery of Goods and Services to Logic Fire and Security Ltd under these Terms and Conditions.

16 Data protection

- 16.1 The Parties acknowledge their respective duties under Data Protection Legislation and shall give each other all reasonable assistance as appropriate or necessary to enable each other to comply with those duties.
- 16.2 Where the Supplier is Processing Personal Data under or in connection with these Terms and Conditions, the Supplier must, in particular, but without limitation:
 - 16.2.1 only Process such Personal Data as is necessary to perform its obligations under these Terms and Conditions, and only in accordance with any instructions given by Logic Fire and Security Ltd under these Terms and Conditions;
 - 16.2.2 put in place appropriate technical and organisational measures against any unauthorised or unlawful Processing of that Personal Data, and against the accidental loss or destruction of or damage to such Personal Data having regard to the specific requirements of Clause 16, the state of technical development and the level of harm that may be suffered by a Data Subject whose Personal Data is affected by unauthorised or unlawful Processing or by its loss, damage or destruction;
 - 16.2.3 take reasonable steps to ensure the reliability of Staff who will have access to Personal Data, and ensure that those Staff are aware of and trained in the policies and procedures identified in Clause 16; and
 - 16.2.4 not cause or allow Personal Data to be transferred outside the European Economic Area without the prior consent of the Logic Fire and Security Ltd.
- 16.3 The Supplier and Logic Fire and Security Ltd shall ensure that Personal Data is safeguarded at all times in accordance with the Law, and this obligation will include (if transferred electronically) only transferring Personal Data:
 - 16.3.1 if essential, having regard to the purpose for which the transfer is conducted; and Terms & Conditions for the Supply of Goods and Services
 - 16.3.2 that is encrypted in accordance with any international data encryption standards, and as otherwise required by those standards applicable to Logic Fire and Security Ltd under any Law and Guidance (this includes, data transferred over wireless or wired networks, held on laptops, CDs, memory sticks and tapes).
- 16.4 Where any Personal Data is processed by any subcontractor of the Supplier in connection with these Terms and Conditions, the Supplier shall procure that such subcontractor shall comply with the relevant obligations set out in Clause 16, as if such subcontractor were the Supplier.

- 17 Freedom of Information and Transparency
 - 17.1 The Supplier shall assist and cooperate with Logic Fire and Security Ltd to enable it to comply with its disclosure obligations under the FOIA, Codes of Practice and Environmental Regulations. The Supplier agrees:
 - 17.1.1 that these Terms and Conditions and any recorded information held by the Supplier on the Logic Fire and Security Ltd.'s behalf for the purposes of any Binding Order are subject to the obligations and commitments of Logic Fire and Security Ltd under the FOIA, Codes of Practice and Environmental Regulations;
 - 17.1.2 that the decision on whether any exemption to the general obligations of public access to information applies to any request for information received under the FOIA, Codes of Practice and Environmental Regulations is a decision solely for Logic Fire and Security Ltd;
 - 17.1.3 that where the Supplier receives a request for information under the FOIA, Codes of Practice and Environmental Regulations and the Supplier itself is subject to the FOIA, Codes of Practice and Environmental Regulations it will liaise with the Logic Fire and Security Ltd as to the contents of any response before a response to a request is issued and will promptly (and in any event within two (2) Business Days) provide a copy of the request and any response to Logic Fire and Security Ltd;
 - 17.1.4 that where the Supplier receives a request for information under the FOIA, Codes of Practice and Environmental Regulations and the Supplier is not itself subject to the FOIA, Codes of Practice and Environmental Regulations, it will not respond to that request (unless directed to do so by the Logic Fire and Security Ltd) and will promptly (and in any event within two (2) Business Days) transfer the request to the Logic Fire and Security Ltd;
 - 17.1.5 that Logic Fire and Security Ltd, acting in accordance with the Codes of Practice issued and revised from time to time under both section 45 of FOIA, and regulation 16 of the Environmental Regulations, may disclose information concerning the Supplier and these Terms and Conditions; and
 - 17.2
- 17.2.1 to assist Logic Fire and Security Ltd in responding to a request for information, by processing information or environmental information (as the same are defined in FOIA and the Environmental Regulations) in accordance with a records management system that complies with all applicable records management recommendations and codes of conduct issued under section 46 of FOIA, and providing copies of all information requested by the Logic Fire and Security Ltd within five (5) Business Days of that request and without charge.
- 17.3 The Parties acknowledge that, except for any information which is exempt from disclosure in accordance with the provisions of the FOIA, Codes of Practice and Environmental Regulations, the content of these Terms and Conditions is not Confidential Information.
- 17.4 Where any information is held by any subcontractor of the Supplier in connection with these Terms and Conditions, the Supplier shall procure that such subcontractor shall comply with the relevant obligations set out in Clause 17, as if such subcontractor were the Supplier.

- 18 Information Security Terms & Conditions for the Supply of Goods and Services
 - 18.1 Without limitation to any other information governance requirements set out in Clauses 15 to 17 (inclusive), the Supplier shall:

19 General

- 19.1 Each of the Parties is independent of the other and nothing contained in these Terms and Conditions shall be construed to imply that there is any relationship between the Parties of partnership or of principal/agent or of employer/employee nor are the Parties hereby engaging in a joint venture and accordingly neither of the Parties shall have any right to act on behalf of the other nor to bind the other by agreement or otherwise.
- 19.2 Failure or delay by either Party to exercise an option or right conferred by these Terms and Conditions shall not of itself constitute a waiver of such option or right.
- 19.3 The delay or failure by either Party to insist upon the strict performance of any provision, term or condition of these Terms and Conditions or to exercise any right or remedy consequent upon such breach shall not constitute a waiver of any such breach or any subsequent breach of such provision, term or condition.
- Any provision of these Terms and Conditions which is held to be invalid or unenforceable in any jurisdiction shall be ineffective to the extent of such invalidity or unenforceability without invalidating or rendering unenforceable the remaining provisions of these Terms and Conditions and any such invalidity or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provisions in any other jurisdiction.
- 19.5 The rights and remedies provided in these Terms and Conditions are cumulative and not exclusive of any rights or remedies provided by general law, or by any other contract or document. In this Clause 19.5, right includes any power, privilege, remedy, or proprietary or security interest.
- A person who is not Logic Fire and Security Ltd or the Supplier shall have no right to enforce any terms of these Terms and Conditions which confer a benefit on such person. No such person shall be entitled to object to or be required to consent to any amendment to the provisions of these Terms and Conditions.
- 19.7 These Terms and Conditions, any variation in writing signed by an authorised representative of each Party and any document referred to (explicitly or by implication) in these Terms and Conditions or any variation to these Terms and Conditions, contain the entire understanding between the Supplier and Logic Fire and Security Ltd relating to the supply of the Goods and Services to the exclusion of all previous agreements, confirmations and understandings and there are no promises, terms, conditions or obligations whether oral or written, express or implied other than those contained or referred to in these Terms and Conditions. Nothing in these Terms and Conditions seeks to exclude either Party's liability for fraud.
